Subject: Type 2 Short Term Rental License Applications Report Update

As a result of City Council action on November 13, 2015, the Austin Code Department (ACD) is not issuing any Type 2 Short Term Rental licenses for applications received after November 12, 2015. Through a memorandum dated November 19, 2015, City Council was provided two spreadsheets identifying existing Short Term Rental (STR) operating license applications divided into two groups. Group 1 included applications received prior to September 17, 2015 (19 applications) and Group 2 includes applications received between September 17, 2015 – November 12, 2015 (25 applications). In summary, 16 STR Type 2 Operating Licenses were issued, 5 licenses were denied and 4 applicants withdrew their applications. Property owners who were denied a license will receive a letter from ACD informing them of the license denial.

ACD staff is continuing to process all 19 applications identified in the Group 1 spreadsheet in accordance with standard review procedures and time limits.
